DUAL ADMISSIONS AGREEMENT

1 Introduction

Community College of Philadelphia, hereinafter referred to as CCP, the College of Arts and Sciences, hereinafter referred to as CAS, and the Campolo College of Graduate and Professional Studies, hereinafter referred to as CCGPS, within Eastern University, hereinafter referred to as Eastern, will enter into this agreement to facilitate the transfer of CCP graduates into CAS and CCGPS colleges within Eastern. CAS and CCGPS welcome CCP graduates via this Dual Admissions Agreement.

2 Terms and Conditions

Under this Dual Admissions Agreement, CCP students will be guaranteed admissions into a parallel Bachelor's Degree program with third year status at Eastern on the condition that they meet the following criteria:

1. Complete a "Dual Admissions Intent" form before completion of 30 college level credits from CCP or any other college or university;
2. Graduate from CCP with any Associate in Science (A.S.), Associate in Arts (A.A.) or approved Associate in Applied Science (A.A.S.) degree (Accounting¹, Nursing² Justice) with a minimum cumulative grade point average (GPA) of 2.0. If applying to an Education major, CCP graduates are required to hold a minimum cumulative grade point average (GPA) of 3.0. (Please see Appendix A for a list of majors included in this agreement);
3. Complete additional Admission Materials as required including the completion of the appropriate CAS or CCGPS application in the final year of CCP degree program. Admission into certain CAS degree programs may require an additional application to

that academic department directly. CCP applicants should contact the Admissions Office for more information.

4. Enroll at Eastern within one year of CCP graduation, not complete more than six credits after graduating and not attend another institution between the time the student graduates from CCP and enrolls at Eastern.

For Eastern University - both the College of Arts and Sciences and the Campolo College of Graduate and Professional Studies:

- Eastern will waive the admissions application fee for both full-time and part-time students and will provide access to ongoing advising while students are attending CCP. CCP students admitted through Dual Admissions are permitted to study full-time or part-time upon enrollment at Eastern.
 - Students can transfer up to 89 credits into both CAS and CCGPS programs. Only courses with a grade of "C" or better are transferrable towards the student's major. A grade of "C" is required to fulfill the written communication requirement. Courses with grades lower than "C" will transfer as electives.
 - CCP Dual Admissions students are required to submit their official CCP, GED certificate or high school and college transcripts from all previously attended colleges and universities prior to enrollment at Eastern.
 - Eastern will ensure that CCP Dual Admissions students entering Eastern under the terms of this Agreement will go through Eastern's enrollment process and therefore must meet all applicable Eastern requirements and deadlines pertaining to orientation and registration, and payment of tuition and fees. They will abide by the policies and procedures, and any revisions thereof, which apply to all Eastern University students.
 - Students will be provided with financial aid information and receive full consideration for financial aid, in addition to the scholarships listed in this agreement, upon matriculation at Eastern.
 - CCP Dual Admissions students must meet all outstanding academic, financial, disciplinary or other obligations to CCP prior to being considered for admission.
 - Spring semester entry to Eastern may affect the normal sequence of courses in a degree program.
 - Eastern agrees to accept the general education courses embedded in the CCP A.A. and A.S. degrees toward the fulfillment of many of its undergraduate general education requirements. Given the larger number of general education courses required for the
-

bachelor degree at Eastern, most students will have remaining general education courses to fulfill after transferring to Eastern, particularly those related to the Christian faith and mission offered only at Eastern.

For Eastern University, Financial Considerations:

College of Arts and Sciences:

- Scholarships will be awarded to all Dual Admissions graduates admitted to Eastern and who meet the scholarship criteria in this agreement. Dual Admissions students enrolling into Eastern's CAS full-time (enrolled in 12 or more credits a semester) with a minimum cumulative 2.0 CCP GPA will be awarded scholarships valued up to \$10,000. This scholarship is renewable each May for the following year provided that students earn a minimum of 21 new credits and achieve satisfactory academic progress within CAS. Students must also maintain a fulltime enrollment status of at least 12 new credits per semester.
- Eastern's policy states that a student may not receive more than the cost of tuition in Eastern funded scholarships and grants. Program participants may apply for all legitimate forms of governmental and non-governmental aid for which they qualify.

Campolo College of Graduate and Professional Studies:

- Eastern will provide a tuition grant in the amount of \$65 per undergraduate credit towards the current year tuition.
- Tuition cost is to be updated annually based on the Eastern fiscal calendar and board approval and communicated to CCP for recruiting purposes.
- Program participants may apply for all legitimate forms of governmental and non-governmental aid for which they qualify.
- The tuition costs, books and associated fees for the program are payable by individual students to Eastern.

Obligations of Eastern University

To facilitate the transfer of CCP graduates to Eastern in accordance with the foregoing guarantee, the parties agree to the following:

1. To attend regularly scheduled Partner Day and Evening Programs at CCP.
-

2. To work with CCP to develop "Dual Admissions Intent Forms" and fact sheets to be distributed to students upon request.
3. To invite CCP students who have completed a "Dual Admissions Intent Form" to informational/advising meeting(s) with faculty and staff at Eastern in order to facilitate smooth curricular and co-curricular integration into Eastern.
4. To send within 30 days of receipt of the "Dual Admissions Intent Form," an Eastern University letter of conditional admission to all CCP students who complete a "Dual Admissions Intent Form" and meet the conditions set forth in this Agreement. In order to assure the best possible housing assignment considerations, students should confirm their intention to matriculate at Eastern as early as possible, but no later than August 1st for the fall semester, and by December 1st for the spring semester, and satisfy all other Eastern transfer requirements. CCP students who complete a "Dual Admissions Intent Form" will be governed by the Eastern degree requirements in effect at the time of signing the "Dual Admissions Intent Form."
5. To work with CCP on Program-to-Program Articulation Agreements that specify how the CCP courses satisfy requirements for degree completion at Eastern.
6. To ensure that CCP Dual Admissions students who matriculate at Eastern have all of the rights and privileges of other Eastern students.
7. To waive placement tests for CCP graduates who have completed a college level Math and English course.

Obligations of Community College of Philadelphia:

1. To publicize this Agreement to prospective and current CCP students in its promotional literature, and make arrangements for Eastern recruiters and advisors to visit with prospective and current Dual Admission Students at CCP Transfer Fair programs in the Fall and Spring as well as Partner Day and Evening programs.
2. To give Eastern the option to promote their programs and to request a list of students who have applied for graduation each semester.

Joint Obligations:

1. To consult with each other through appropriate channels prior to implementing significant changes in policy or curricula that directly affect students transferring under the terms of this Agreement, and keep each other informed of any other changes of policy or curricula that affect those students.
-

2. To collaborate in providing students with information and academic advising about this Agreement, Eastern's academic requirements, and the process of transferring to Eastern.
3. To develop and implement advertising and promotional efforts to communicate the benefits of Dual Admissions.
4. To designate a representative or representatives at each institution who will coordinate the Dual Admissions Agreement between both institutions.
5. To exchange data and documents annually that will contribute to the maintenance and improvement of this agreement, enhance the transfer process, and promote effective cooperation between institutions. These will consist of aggregate data about transfer students, including admissions information, academic progress and retention information, and reports on the results of program reviews, assessments of student learning, and decisions of curricular and other committees. Each institution will exchange data after obtaining appropriate permission from the students as indicated on the "Dual Admissions Intent Form."
6. To facilitate and support consultation and collaboration between their faculties related to this agreement, general education, degree requirements, and other academic matters.
7. To provide direct links between Eastern and CCP websites.


Revision, Renewal and Termination of this Agreement:

Eastern's Provost's office and the Office of the Vice President of Academic Affairs at CCP are responsible for identifying, and communicating to each other, changes in the policies or requirements of their respective institutions that affect this Agreement. Such changes will become effective when both CCP and Eastern sign a revised document.

This agreement will be in effect as of the date of its signing. It will be reviewed annually by the appropriate parties at each institution, and will be renewed automatically until superseded by a new agreement or formally terminated. Either institution may terminate this Agreement at any time by written notice at least one year in advance of the effective date of termination. Should this agreement be terminated, it is understood that the termination will not apply to students already accepted to Eastern under the terms of this agreement.

The willingness of both institutions to enter this agreement in order to facilitate the transfer of students from CCP into Eastern, and to expand their opportunities for academic success there, is indicated by the following signatures:







SUBJECT: Revised Dual Admissions Agreement with Eastern University

The Transfer Team has reviewed and recommends support of a revised Dual Admissions transfer agreement between Community College of Philadelphia and Eastern University. Our College signed the original Dual Admissions agreement with Eastern 13 years ago when it was still Eastern College. Since then many things have changed at both of our institutions.

This newly updated agreement:

- 1) Clarifies the differences between the two Colleges within Eastern University for which this agreement pertains:
 - College of Arts and Sciences
 - Campolo College of Graduate and Professional Studies
- 2) Updates the scholarship/tuition grant money available to students.
- 3) Updates and clarifies the list of appropriate Eastern University majors with the appropriate matching CCP majors.

Please find attached two original copies. If you support this updated agreement, please sign both copies which will be sent to Eastern University for signatures. Community College of Philadelphia will retain one copy with the signatures of representatives from both institutions.

Preface

Community College of Philadelphia (CCP) and Eastern University (EU) enter into this Program-to-Program Transfer Agreement (Agreement) to facilitate the transfer of CCP students to EU. This Agreement focuses on the transfer of CCP students who earn an Associate in Arts in Education: Early Childhood (Birth to 4th Grade). CCP students seeking transfer to EU under this Agreement qualify for dual admissions. This Agreement applies to students who enter EU as full-time or part-time undergraduate students.

The Agreement

Subject to the terms of this Agreement, students who complete the Associate in Arts (A.A.) in Education: Early Childhood (Birth to 4th Grade) at CCP and meet EU's entry requirements are assured third-year, junior status in EU's Bachelor of Science Degree (B.S.) in Early Childhood Education OR Early Childhood Studies. This will position a full-time student to fulfill requirements for the Bachelor's degree within four regular semesters.

The following terms and conditions apply for CCP graduates entering the **Accelerated Education Studies (ACES)**:

- 1.e Graduate from CCP with the A.A. in Education: Early Childhood (Birth to 4th Grade) as described in the transfer guide included in this Agreement.e
- 2.e Earn a final cumulative CCP grade point average of at least a 2.5 for entrance intoe the Early Childhood Studies Program.e
- 3.e Meet the requirements of the Child Protective Services Law, 23 Pa. C.S.A., sectione 6344 (relating to prospective childcare personnel).e
- 4.e Meet deadlines for admissions application, payment of fees and other enrollment requirements that apply to other entering students at EU.e
- 5.e Enroll directly to EU within two years of completing an associate degree programe of study from CCP and not attend another institution between graduation ande attendance at EU.e

The Education Studies Major does not require taking/passing the Basic Skills tests and leads to a B.S. degree only. Education Studies students have the option to take student

teaching in our post baccalaureate program after graduation, provided they have passed the Basic Skills test and have a GPA of 3.0 or better. With courses, student teaching and exams completed, students would be eligible to complete certification in Pre K to 4th grade.

The following terms and conditions apply for CCP graduates entering the **Accelerated Early Childhood Education (ACED)**:

- 1.e Graduate from CCP with the A.A. in Education: Early Childhood (Birth to 4th Grade) as described in the transfer guide included in this Agreement.e
- 2.e Earn a final cumulative CCP grade point average of at least a 3.0 for students seeking acceptance to the Early Childhood Education (also referred to as the teacher preparation program).e
- 3.e Obtain qualifying scores on PAPA or equivalent paths at the time of application as outlined in the transfer guide included in this Agreement for the Early Childhood Education program.e
- 4.e Meet the requirements of the Child Protective Services Law, 23 Pa. C.S.A., section 6344 (relating to prospective childcare personnel).e
- 5.e Meet deadlines for admissions application, payment of fees and other enrollment requirements that apply to other entering students at EU.e
6. Enroll directly to EU within two years of completing an associate degree program of study from CCP and not attend another institution between graduation and attendance at EU.

Dual Admissions

In addition to the conditions mentioned above, students interested in pursuing and qualifying for the benefits of transfer through the Dual Admissions Agreement are required to:

- e Submit an electronic Dual Admissions Intent form before completion of no more than 30 graded college level credits from all colleges/universities attended.e

Benefits of dual admissions include:

- e Application fee to EU will be waived.e
- e Merit Scholarships for dual admissions students who do not receive the T.E.A.C.H.e (Teacher Education And Compensation Helps) Early Childhood[®] PENNSYLVANIA Scholarship and enroll at EU full-time (12 or more credits) or part-time (6 to 11 credits) with a 3.0 or higher cumulative CCP GPA.e
- e Informational meetings with EU staff at EU's campus and CCP's main campus for assistance in matriculating to EU.e

Students previously matriculated to EU are not eligible for the EU dual admissions program.

Students are strongly encouraged to meet with an EU Admissions Representative and/or a CCP Transfer Counselor, Academic Advisor or Curriculum Coordinator to develop a course taking strategy to maximize course transferability.

Transfer and Academic Guidelines

- 1.e Graduates of the A.A. in Education: Early Childhood (Birth to 4th Grade) program at CCP will be admitted with third-year (junior) status to EU. Students who enroll full-time will be able to complete the B.S. in Early Childhood Education or Early Childhood Studies degrees within four full-time fall/spring semesters provided they complete the appropriate sequence of their remaining course work at EU.e
- 2.e EU requires matriculated students to complete half of their major courses at EU.e EU will accept a maximum of 89 credits in transfer.e
- 3.e Grades of "C" or better will be regarded as "satisfactory" performances. Courses in which grades of "C" or better have been earned will be accepted for transfer.e Grades of "D" may be accepted for non-major courses.e
- 4.e To be admitted to Eastern University's Early Childhood Education degree program, students need passing scores as established by the Pennsylvania Department of Education (PDE) on the Pre-Professional Skills tests. (Reading, Writing, Listening, Mathematics). In accordance with PDE requirements, the GPA requirements for students seeking acceptance to the Early Childhood Education (also referred to as the teacher preparation program) in the College of Education is 3.0.e
- 5.e EU will need official transcripts for evaluation of credit from all institutions attended including military transcripts. Credit will also be awarded for AP, CLEP, etc. with appropriate documentation. Developmental courses are not eligible for transfer.
- 6.e CCP will identify all courses that are credit for experience with the identification of "S" for *satisfactory*; this applies only to the Birth-through Grade 4 Program at CCP. EU will transfer credits from CCP for education courses completed with "S."e Students with an "S" have satisfactorily met the assigned course-based competencies with a "C" or better. The credits for these courses transfer in as a part of this Program-to-Program agreement.e
- 7.e CCP students who transfer are responsible only for requirements in place at EU at the time of the student's enrollment in the AA Education: Early Childhood (Birth to 4th Grade) curriculum at CCP.e
- 8.e Students who have pursued a CCP associate degree other than the A.A. in Education: Early Childhood (Birth to 4th Grade) or who do not earn the associate degree prior to transfer to EU are not covered by this Agreement. Such students will be considered for admissions on an individual basis and their credits will be evaluated on a course-by-course basis.e

Financial and Scholarship Incentives

To encourage CCP graduates to transfer to EU, EU agrees to the following:

Application Fee: To waive the application fee for students who apply to EU.

Academic Scholarships:

- e This Agreement is funded through a grant from the William Penn Foundation in support of the early childhood education workforce in the Philadelphia region

to build strong aligning career pathways. Students working in the early childhood education field and who choose to transfer from Community College of Philadelphia to Eastern University under this Agreement may apply for the Pennsylvania Child Care Association's T.E.A.C.H. (Teacher Education And Compensation Helps) Early Childhood® PENNSYLVANIA Scholarship Program. This scholarship enables students to receive ninety percent of their tuition costs.

- e EU will offer a 20% discount to students matriculating from CCP into EU's ACED or ACES programs if they do not receive the T.E.A.C.H. Early Childhood® PENNSYLVANIA Scholarship whether the students are Dual Admissions or not.e
- e Dual Admissions students who do not receive the T.E.A.C.H. Early Childhood® PENNSYLVANIA Scholarship are eligible for the dual admissions tuition grant as noted in the Dual Admissions Agreement.e

These scholarship/tuition grants are not stackable, meaning that EU cannot provide both a Dual Admissions grant plus additional financial benefits associated with this P2P. However, if students qualify for both the Dual Admissions Tuition Grant and benefits associated with this P2P, Eastern will award the greater of the two.

Scholarships may be renewed each year contingent upon the students submitting their FAFSA and remaining in good academic standing at EU. e

Financial Aid: To provide students with EU financial aid information and receive full consideration for EU financial aid upon matriculation at EU. Financial Aid will be awarded to transfer students on the same basis as traditional EU students. They will have equal access to all state and federal financial aid programs.

Students are strongly encouraged to complete the Free Application for Federal Student Aid (FASFA) before May 1st each year to determine if they are eligible for a state grant.

Obligations of The Agreement

To facilitate the transfer of CCP graduates to EU in accordance with the foregoing guarantee, the parties agree to the following:

- 1.e To encourage CCP students to meet with representatives from EU for discussion of issues related to admission and financial aid well in advance of their expected date of entry to the transfer institution. To facilitate this, EU will participate in student outreach (e.g.: transfer fairs, campus visits, virtual open houses, etc.) at least once each semester each fall/spring semester. Students who transfer under this Agreement are eligible for housing and financial aid on the same basis as native EU students with junior status.e
- 2.e To collaborate in providing students with information and academic advising about this Agreement, EU's academic requirements, and the process of transferring to EU.e
- 3.e To assure that appropriate personnel in their respective institutions are aware of this Agreement, will support it and will designate a representative to serve as an institutional liaison to distribute information and maintain the Agreement.e

- 4.t To encourage faculty from each institution teaching in the curriculum for which this Agreement has been developed to meet at least annually to discuss issues of curriculum and student development.t
- 5.t To consult with each other through appropriate channels prior to implementing major changes in policy or curricula that directly affect students transferring under the terms of this Agreement, and keep each other informed of any other changes of policy or curricula that affect those students. Both EU and CCP will review this Agreement annually and make any changes upon mutual agreement, as needed.t Such changes will become effective when both CCP and EU sign the revised document.t
- 6.t To collaborate on research activities to help assess the effectiveness of this Agreement in meeting the needs of students.t
- 7.t To exchange aggregate data annually that will contribute to the maintenance and improvement of this Agreement, enhance the transfer process, and promote effective cooperation between institutions.t
- 8.t Students from the Philadelphia area who apply but are not admitted to EU will be sent a letter encouraging them to attend and earn an appropriate associate degree from CCP so as to take advantage of the benefits of this Agreement. CCP will receive a list from EU of students denied and sent this letter so that they can follow up with the students.t
9. ~~EU will encourage CCP transfer students to complete the appropriate associate degree before matriculation to EU in order to take advantage of this Agreement. If the CCP student chooses to transfer and matriculate to EU before completion of the associate degree, EU will encourage reverse transfer. EU will develop a reverse transfer credit process, which must be mutually agreed upon by both EU and CCP, that includes methodology to notify and assist students with this reverse transfer benefits.~~
- 10.t The parties will abide by their respective policies of nondiscrimination in regard to sex, age, race, color, creed, national origin, disability, sexual orientation, gender identity, veteran status or any other status protected by Title VI of the Civil Rights Act of 1964, Title IX of the Education Amendments Act of 1972, the Americans with Disabilities Act, or any other applicable federal, state, or local law. The parties agree to reasonably cooperate with each other in any investigation of claims of discrimination or harassment, to the extent permitted by law.t

Revision, Renewal and Termination of this Agreement

Eastern University's Provost and Vice President for Academic Affairs and the Vice President for Academic & Student Success at Community College of Philadelphia or their designees, are responsible for identifying, and communicating to each other, changes in the policies or requirements of their respective institutions that affect this Agreement. Modifications to the terms and conditions of this Agreement may only be made by written agreement of the parties. Until such modification by mutual written agreement, the then-current terms of the Agreement shall remain in effect.

This Agreement will be in effect as of the date of its signing, for students entering EU on or after Fall 2019, and will continue in effect for five (5) years unless otherwise modified or terminated in accordance with this Agreement. Either institution may terminate this


Agreement at any time by written notice at least one year in advance of the effective date of termination. Should this Agreement be terminated, it is understood that students already accepted to EU through the effective date of termination will continue to receive the benefits articulated in this Agreement.

Provided that all parties execute a copy of this Agreement, this Agreement may be executed in counterparts, each of which shall constitute an original, and all of which together shall constitute one and the same document. This Agreement may be executed by the parties and transmitted by facsimile or electronic transmission, and, if so executed and transmitted, shall be effective as if the parties had delivered an executed original of this Agreement.

The willingness of both institutions to enter this Agreement in order to facilitate the transfer of students from CCP into EU, and to expand their opportunities for academic success there, is indicated by the following signatures.

General Information: This guide reflects the requirements for the Associate in Arts (A.A.) in Education: Early Childhood (Birth to 4th Grade) in the Spring 2018, 2018-2019 and 2019-2020 College catalogs at Community College of Philadelphia for transfer to the Bachelor of Science (B.S.) in Early Childhood Education OR Early Childhood Studies at Eastern University. A grade of "C" or higher is needed for courses to transfer. Completion of this A.A. leads to junior standing in the B.S. in Early Childhood Education OR Early Childhood Studies at Eastern University.

All undergraduate candidates seeking an initial state-approved Pennsylvania educator preparation certificate are required to pass a basic skills assessment as well as the corresponding subject matter test(s) related to the certification area. There are a variety of tests/scores students can use to pass their Basic Skills Assessment (BSA) requirement: ACT, CORE, PAPA or SAT.

Options to pass the Basic Skills Assessment:

- e Minimum scores for each module - math, reading, writing - are noted on the Pennsylvania Department of Education website. Access the website for requirements and test registration links under Certification Tests and Requirements:e

- e Eastern University recommends that students take Community College of Philadelphia's MATH151 and MATH161 OR MATH 123 and MATH 133. These PDE approved math courses count towards meeting Basic Skills Math requirement. The two courses must be taken as a pair - that is MATH 151 must be followed with MATH161 OR MATH 123 must be followed with MATH 133.e

Transfer guides are created and maintained to help students and staff make appropriate course and program choices. The guides show how the requirements for the appropriate Community College of Philadelphia associate degree transfer to the bachelor's institution. It is, however, possible for program requirements at Community College of Philadelphia or the transfer institution to change without advanced notice.
