- b. Stan Walling raised a concern regarding the ratio of online and in person courses this fall. There was general uncertainty as to whether such ratios were within the purvey of this committee
- c. Charletha Porter raised the question of whether parking would continue to be free past this spring semester. Derrick Sawyer informed the committee that free parking would be highly unlikely to be free past this May due to the end of HERF federal dollars which had previously provided funding for the maintenance of the parking garage at the Main campus. There was a suggestion to raise awareness of that arrangement so that the College community writ large would better understand why free parking will end in May.

a. Stan Walling moved to adjourn the meeting. John Wiggins seconded the motion. Motion passed unanimously. Meeting was adjourned at 1:54 pm
