CIS 100 is being replaced with CIS 103 in order to comply with the new Technological Competency requirement. One social science is being eliminated from the program. The net effect of these two changes is that the minimum number of credits required for graduation is decreasing from 68 to 67.

English 120-Voice and Articulation is being added as a choice under the Humanities Elective since this is a useful elective for students in this program.

Students will fulfill their Writing Intensive and Interpretive Studies requirements through their science or social science elective.
