of Philadelphia. A copy of the agreement was sent separately by Bridget to the IWC members. The agreement describes an expedited review process for 25 curricula which are in the Spring 2018 catalog. Committee members have an opportunity for comment. In addition, there are 18 curricula that will have a full review.

Bridget read a second document, "Curriculum Committee Review Process Clarification" which also was sent to the IWC by Bridget. After Bridget read the document Judy Gay asked for a clarification based on Bridget's interpretation of the language. Members of the IWC discussed the language of the documents. The IWC makes recommendations to the president, whether they are positive or negative and then forwards the recommendation to the president for a decision.

There was a discussion of the process for the 25 curricula on the agenda. The IWC agreed that committee members will submit comments in writing by November 15<sup>th</sup> to Natalie Price. The IWC will discuss the curricula at the November meeting. The IWC agreed that comments for all programs will be sent to all department heads.

- C. Scholarships for Students

Verna Gillins introduced the topic of helping students find out about scholarships. Troy Bundy stated that there are workshops for students and there are emails about the workshops.
