III. New Business

Discussion with Dean Asencio

With a new dean, some of the Student Code may change. It is to be determined if a behavioral intervention group will be started again, and decide what the group should handle. The dean has experience developing an intervention group, establishing hubs of communication around the institution would that will inform others about issues, etc. in regular meetings. Also, what would this look like at the Regional Centers? Each of them would need a team. Student names/issues would surface during the meetings, and the team would discuss how to handle the incidents, in a timely manner. A counselor or the dean would decide who at the College would handle the student further. This was used as a safety net and not necessarily part of the code of conduct. Some issues would arise because of Maxient reports, some are repeated behaviors and some arise out of the meeting conversations. Dean Asencio is used to dealing with most issues informally with students and wanting them to have a learning experience, not just have it be a punitive action. This is different than a threat assessment team.

Also, at his last institution, they did not use "accused or alleged," they used the term "referred student."

Dean Asencio will draft a plan and share with the College community.
