**Technology environment**

- Jane suggested the use of smart boards.
- DiBlasi shared his experience at a conference at Montgomery County Community College; the presentation by Villanova University's engineering department about lecture-capture technology with a combination of video and audio equipment.
- Hirsch shared his experience of how technology has been used at a local university in Nashville, TN. The equipment is based in one place but controlled appliances in four different rooms.
- DiBlasi mentioned that podcasts can be implemented quickly at the College with support from the ITS department.
- Access to printing; Improve faculty access to printers.
  1. Privacy laws need to be considered
  2. DiBlasi: the ability to print secure documents already exists at the College. Its use will decrease the likelihood of confidential documents been viewed by all.
- Wireless access in the classroom will provide flexibility for the professor.
- DiBlasi: Many of the points presented have been considered and many have been incorporated in the renovation projects for the main campus.
- Discussion about the use of a SMART cart compared to a podium.
- Hirsch suggested that we include student voices in the design of new classrooms (e.g. student focus groups). Also, the group should consider the group should consider new designs for student kiosks.
- Bixby mentioned that when considering classroom technology, he recommends a discussion about assistive technology.
- Enhance live courses with a hybrid component.
- Freeman: Will students or faculty drive the changes?
- Brief discussion about College alumni's access to College email took place. The group agreed that it's an area that needs more discussion.
- Expanding technology access to students to use in and out of the classroom.
- Using social networking in the portal to engage current student.
- Electronic books.

- Hirsch again suggested the inclusion of assistive technology.
  - Hawk: In thinking about the classroom of the future, what type of equipment would students and faculty need in the classroom?
- **Discussion:** Would it be possible for the College to play a role in providing broadband access? Bauer is working with wireless Philadelphia.

**Interim reports:**

- Bromley: Internet access has been increased exponentially in the last few years. Network/IP are running at 20 to 25 percent capacity. We can see the type of traffic coming in and out of the College and new circuit upgrade will take place in the next few months.
- Hawk: report is not completely ready yet, but a draft will be ready by the next TCC meeting.
- Bauer: The communication team is still working and is planning to meet soon.
- Looking at opportunities in Luminis portal and installing Resource 25 software product. Will outline all opportunities at the next meeting.
