- IV. Business
 - a. **Update on the Migration of Students in AD/Office 365**
 - i. SK Calkins and Bill Bromley discussed the transition of our students into the Office 365 and AD environment.
 - 1. A pilot of approximately 44 students started this week. Once the pilot is complete, all current students will have a new email address with the domain change of @student.ccp.edu. Their old email address @ccp.edu is currently housed in Google and will remain as an archive for approximately 1 year following our Go Live in May 2017.
 - 2. A communication to students and faculty will be reviewed by Marketing. The transition to Office 365 email is anticipated the occur on the week of May 8th.
 - 3. All students will have the same password they currently use to login to the MyCCP portal. During the Summer terms we will pilot the Password Reset utility for students.
 - a. The same Password Reset utility that faculty and staff use now will be provided to students to authenticate and reset their password. The rollout period for all students to utilize the Password Reset functionality will be determined within the Fall semester based on the outcome of the pilot.
 - 4. As we move through the summer terms, students will reside in both Google and O365 for email. Their primary account will be in Office 365 (@student.ccp.edu). They will be allowed to forward messages from the @ccp.edu (gmail) account but will only receive in the @student.ccp.edu account.
 - 5. This move into AD for students will facilitate the new Print Management implementation and will allow students to have access to the Microsoft Download Center for MS Office and other MS Products.
